HOW TO OPEN AN ACCOUNT

Young Saver accounts must be opened by a Trustee aged over 18 such as a parent, guardian or grandparent, who will have overall responsibility for the account until the child turns 16, then their account is changed to a standard membership account.

For the Young Saver you will need to provide:

1. ☐ Completed Young Savers Application Form
2. ☐ Proof of ID of the Young Saver—birth certificate or passport

The Trustee will also need to provide:

1. ☐ Trustee's Photo ID e.g. passport, driving licence
 2. ☐ Proof of Trustee's address e.g. utility bill, Council Tax bill, an official letter from a government dept etc.
